

Dear Parents,

We are excited to open registration for our Tiny Tots program for the 2015-2016 school year. The program operates from September 8th, 2015 through May 20th, 2016. The goal of our program is to introduce pre-school age children (3-4 years of age) to a classroom style setting. Our objective is to enhance your child's social skills and better prepare them for school. We provide educational time, which includes identifying numbers, alphabet, and colors, plus a visit from Library personnel. The children will participate in various activities which include but not limited to class work, free active play, constructive play, centers, and various arts and craft activities. We also have two programs at the end of each semester which includes a Christmas Play on December 18th and a graduation ceremony on May 20th.

The cost of the program is \$60.00 a month. We are open Monday-Thursday from 7:30-11:30am. We offer a bus service home at the additional cost of \$10.00 a month; however, your residence must be within the Thomasville City limits. If you are not sure, please speak with the Center Director. There must be an adult present when the children are dropped off at home. If they are not present the children will return to the center and normal late fees will be assessed as if they were not picked up.

We are closed on the following days:

September 7th: Labor Day

November 25th-27th: Thanksgiving Break

December 23rd-January 1st: Christmas Break

January 18th: MLK Day

March 25th-April 1st: Good Friday and Spring Break

Children will need to bring a change of clothes and a snack every day. We recommend children wear closed toe shoes. Please send your child with a book bag. We will send homework home with them as well as monthly calendars and reminders about upcoming activities that require your attention.
